

**PENGUMUMAN PENGAMBILALIHAN  
PT BANK COMMONWEALTH**

Dalam rangka memenuhi ketentuan Pasal 133 ayat (2) Undang-Undang Nomor 40 tahun 2007 tentang Perseroan Terbatas, Pasal 38 huruf (a) Peraturan OJK No. 41/POJK.03/2019 tentang Penggabungan, Peleburan, Pengambilalihan, Integrasi, dan Konversi Bank Umum, Pasal 4 Peraturan OJK No. 31/POJK.04/2015 tentang Keterbukaan Informasi atau Fakta Material oleh Emiten atau Perusahaan Publik dan Pasal 27 Peraturan OJK No. 37/POJK.03/2019 tentang Transparansi dan Publikasi Laporan Bank, dengan ini PT Bank OCBC NISP Tbk ("OCBC") mengumumkan bahwa pengambilalihan 100% saham PT Bank Commonwealth (PTBC) oleh OCBC, yang semula dimiliki oleh Commonwealth Bank of Australia sebesar 99%, dan pemegang saham lainnya sebesar 1%, berdasarkan Akta Pengambilalihan No. 43 dan Akta Jual Beli Saham No. 44, masing-masing tanggal 30 April 2024 yang dibuat di hadapan Fathiah Helmi, S.H., Notaris di Jakarta, telah selesai dan efektif pada tanggal 1 Mei 2024 ("Pengambilalihan").

Sehubungan dengan Pengambilalihan tersebut, OCBC telah memperoleh persetujuan-persetujuan yang diperlukan termasuk dari Otoritas Jasa Keuangan ("OJK"), sebagaimana tertera dalam Keputusan Anggota Dewan Komisiner OJK No. KEPR-25/D.03/2024 tanggal 29 April 2024 tentang Izin Pengambilalihan 100% Saham PTBC oleh OCBC.

*To fulfil the provisions of Paragraph 133 article (2) of Law Number 40 Year 2007 on Limited Liability Company, article 38 point (a) OJK Regulation No. 41/POJK.03/2019 on Merger, Consolidation, Acquisition, Integration and Conversion of Commercial Bank, article 4 OJK Regulation No. 31/POJK.04/2015 on Disclosure of Material Information or Fact by Issuer or Public Company and article 27 OJK Regulation No. 37/POJK.03/2019 on Transparency and Publication of Bank Report, we, PT Bank OCBC NISP Tbk ("OCBC") hereby announce that the acquisition of 100% shares of PT Bank Commonwealth (PTBC) by OCBC, from the previous shareholders, Commonwealth Bank of Australia of 99%, and other shareholders of 1%, based on the Acquisition Deed No. 43 and the Sale and Purchase Deed No. 44 both dated 30 April 2024, drawn up before Fathiah Helmi, S.H., Notary in Jakarta, is completed and effective on 1 May 2024 ("Acquisition").*

*In regard to this Acquisition, OCBC has obtained the necessary approvals including from the Financial Services Authority of Indonesia ("OJK") as stated in OJK Board of Commissioners Decision No. KEPR-25/D.03/2024 dated 29 April 2024 on the Approval for the Acquisition of 100% shares of PTBC by OCBC.*
